WE write this protest letter on behalf of the Western Australian Muslim community expressing our abhorrence at *The West Australian* Alston’s depiction of West Australian Muslims in the ‘Jihad (Southwest Cell) cartoon published in the *Weekend West Australian* on 2 November 2013.

Our respected and law abiding members of the Muslim community if required will offer every assistance to federal and local law enforcement agencies to help solve this bizarre discovery of lethal bomb making chemicals. No credible evidence or adverse criminal intelligence published data that we know incriminates our local Muslim community. So what is the actual purpose and agenda of this sub-standard fear-mongering and islamophobic racist cartoon?
